

Silicon epitaxial planar type

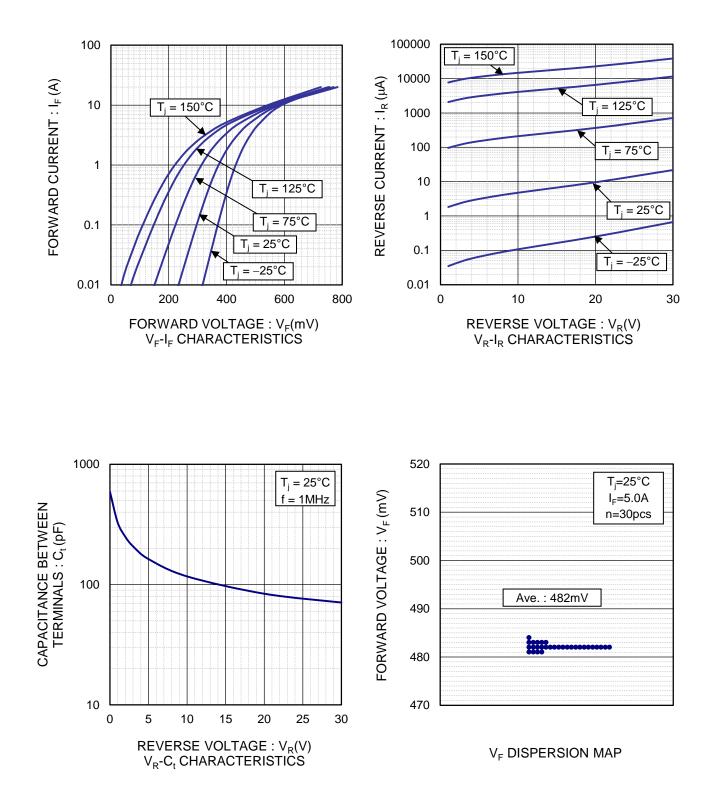


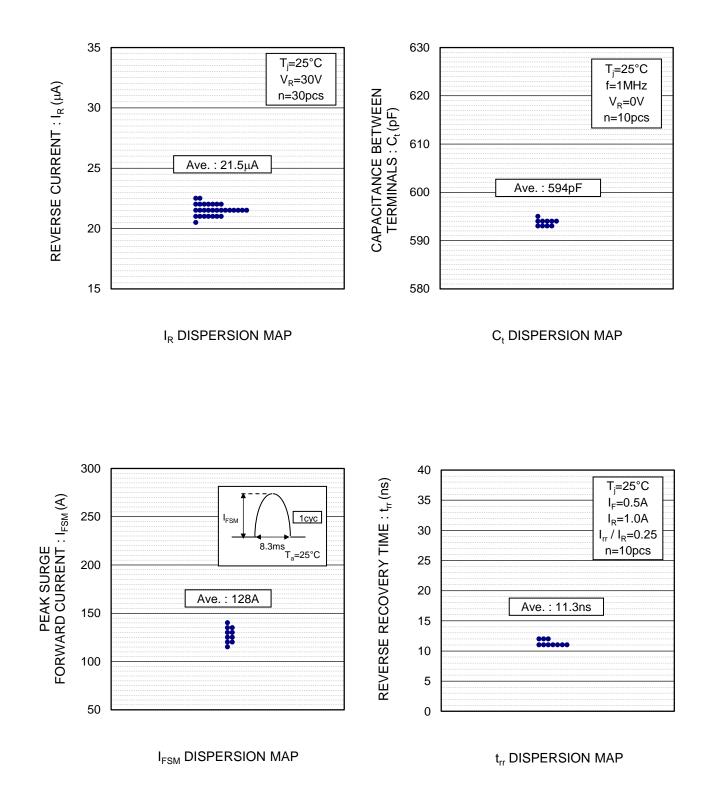
